RCS has experienced tremendous growth in our high school immigrant student population. These students have unique challenges and the ESL Department is requesting a high school enrollment facilitator to support these students throughout their high school years. Many of the high school immigrants have interrupted schooling and this presents challenges in scheduling students within a timeframe for successful graduation. Without an advocate who can create a solid graduation plan and offer a system of support as well as accountability many will drop out of school.

14. PURCHASE OF PROPERTY

Blackman Property

The City of Murfreesboro has issued a Will Serve Letter to provide sewer to schools on the Batey property. The Will Serve Letter is contingent upon certain amendments to the City's ordinances and normal requirements for sewer. The City has worked well with school system staff to get sewer to the Batey property. The amendment to the City ordinance will require approximately 30 days. As previously reported, all test results have shown normal conditions for construction. The property is under two contracts. One contract is for 59.1 acres. The second is for the house and 2.29 acres. The parcel consisting of 59.1 acres has appraised for \$4,500,000.00. The house and surrounding 2.29 acres have appraised for \$730,000.00. Both contracts have been amended to provide for the purchase of the properties at the appraised prices. The purchase will be contingent upon approval of funding by the Rutherford County Commission. The Bateys agreed to extend the inspection period to May 15th.

Recommended Approval---motion to move proceeding with the purchase of the Batey properties subject to the City providing sewer and County Commission approval for funding, and to proceed with requesting county commission approval for funding as presented.
