9. HUMAN RESOURCES (TAB 2)

I. 2025-2026 Signing Bonus Incentive for Hard to Staff Subject Areas

11. ENGINEERING AND CONTRUCTION (TAB 4)

I. Thurman Francis Gym/Auditorium Sound System: Dr. Mark Gonyea is partnering with the Experience Church to replace the gym/auditorium sound system. The cost for this replacement is \$20,619.70 and is being completely covered by the Experience Church. Engineering and Construction has reviewed the request and has no objections.

Recommended Motion - to approve the Thurman Francis sound system request, as presented.

II. Roy Waldron School Nutrition Painting Project: The School Nutrition department has been reviewing options to upgrade the appearance of the cafeteria serving line areas for a couple years. Currently, they are requesting to begin a second school serving line project with Roy Waldron Elementary. The cost for this project is \$60,716.55 and will come from the fund balance and will not require additional funds. The Engineering and Construction department has reviewed the request and has no objection.

Recommended Motion - to approve the School Nutrition request for Roy Waldron Elementary as presented.

III. Rocky Fork Middle Softball Request: Principal Jennifer Clark is requesting to install concrete around the girls' softball backstop to improve the fan sitting area. This project is being donated by GP Concrete and the estimated cost is \$5,670.00 and at no cost to the Board. Engineering and Construction has reviewed the request and has no objection.

Recommended Motion - to approve the Rocky Fork Middle softball backstop request as presented.

IV. Whitworth Buchanan Baseball Field Request: Principal April Sneed is requesting to install artificial turf at home plate of the baseball field. The cost for the project is \$4,000.00 and is being funded through the baseball account. The request is at no cost to the Board. Engineering and Construction has reviewed this request and has no objection.

Recommended Motion - to approve the baseball turf request for Whitworth Buchanan as presented.

V. Smyrna High School Adjacent Lot Development: Engineering and Construction has been approached by the City of Smyrna, GMC Design and Southeast Development concerning the plans for the adjacent lot. Engineering has had meetings to discuss the TDOT approvals and the effects on our campus. We will be discussing this with the Board and possibly requestion a motion on 35 acres of land that is mostly in a flood plain.

The policy committee reviewed Policy 5.118 – Background Investigations

Adds language regarding background checks and FBI rap back program for employees and other individuals having proximity to students.

Discussion held:

Ms. Ridley indicated that the committee needs to decide whether contractors and volunteers will be included in the rap back program and if we are going to reimburse any costs for these. Ms. Ridley mentioned that the rap back program is a Federal FBI program that gives continuous updates on background checks. Currently, the background check gives a snapshot of what is on their background at that time, and we have to re-screen employees every 5 years.

Ms. Ridley also mentioned that the cost is \$50 per employee or contractor and then in addition to that is the \$37 fee for fingerprinting so altogether, the cost is \$87 per person.

Motion made by Ms. Sharp and seconded by Ms. Rosales to revisit adding contractors and volunteers to Policy 5.118 at the next policy meeting.

Dr. Sullivan mentioned that TSBA and TBI had recommended to go with the employees.

Motion made by Ms. Darby, and seconded by Ms. Sharp to strike from page 2, line 17 contractors and volunteers.

Vote: All yes

Discussion was held on striking from page 1, lines 28 & 29. Ms. Ridley indicated that we need to keep on page 1, line 28 and on page 2, lines 1-7 if we are not adding contractors and volunteers to the rap back program.

Ms. Darby suggested changing the language on line 24 to read "the board shall pay expenses

related to the rap back program."

background checks and fingerprinting shall be paid by the Board" and lines 24 & 25 stricken, line 4,

8. PUBLIC COMMENT*

- 1) Hannah Stromgren Wife, mother and current EMT, comes to the board in opposition of book banning. She feels books provide comfort and help for children when parents cannot help. She stated this is about children and asking to give kids a choice and not giving away what little choices they have.
- 2) Daphne Gamble Not present
- 3) Ellen Myrick Spoke about author Laurie Halse Anderson, whose book *Speak* is to be discussed tonight. The author is a recipient of Astrid Lindgren Memorial Award. Ms. Myrick said *Speak* has saved thousands of young lives and book needs to be accessible. She is asking the board not to silence *Speak*.
- 4) Bryan Schuster Read the TN state law as it pertains to "sexually explicit" material in books and asked the board to adhere accordingly. Mr. Schuster read excerpts from a book being discussed this evening and asked the audience to raise their hands once they heard sexually explicit language.

- 5) Matt Fee Mr. Fee stated that when a law is unjust, civil disobedience is required. Rutherford County has zero respect for librarians. He stated there is zero consistency except one board member that wants all the books gone. He said we must be active in our community and speak out or things like this will continue to erode our civil liberties.
- 6) Gary Carter Mr. Carter is a bus contractor and came to address the board about the 34.8% raise bus contractors are asking for. He provided examples of related cost to the board and explained why the bus contractors need an increase.
- 7) Elizabeth Shepherd Ms. Shepherd is a Blackman HS parent and a school librarian. She quoted author Laurie Halse Anderson and shared how the author's book *Speak* held a special place in her heart and wished it was required reading for teenagers. Students are reading it, in high circulation and asks the board not to remove the book from libraries. Furthermore, she cannot support a resolution that basically says hurry up and close the borders to keep non-English speakers out.
- 8) Barbara Donnell Ms. Donnell is a Trustee with the Rutherford County Bus Organization, a bus contractor. She said bus drivers cannot continue to operate buses without a raise. Ms. Donnell elaborated that it would be more economical to negotiate a contract with the bus contractors than to go out and purchase our own buses, provide new employees/benefits, parking and maintenance building.
- 9) Jeffrey Wiencek In support of the removal of books not suitable for students in schools. He asked the board to listen to their constituents as their actions are not aligned with the citizens that elected them.
- 10) James Olexa He stated that complaints or disagreements regarding a book should be made at the state level and commends the board for finding a middle ground by allowing parental consent on some books. His concern is with the board members that consistently vote to abstain or retain books. Board members are chosen to represent their constituents and by abstaining is disrespectful.
- 11) Heather Cook Opened in prayer, said we are in a spiritual battle and stands for our children. She continues to be in support of removal of books that are deemed inappropriate for children.

- 2 A parent/guardian of a student enrolled in kindergarten through second grade may choose to retain
- 3 his/her student in the current grade level if:
- 1. The student has a documented academic or behavioral delay; and
- 5 2. The parent/guardian believes that retention may benefit the student.
- 6 If a parent or guardian elects to retain the student, the parent or guardian shall notify the student's school

9 PROMOTION PLANS⁶

- When a student is identified for retention, the student's parent(s)/guardian(s) shall be notified within

- 21 the strategies shall be modified. Parent(s)/guardian(s) shall be provided with any changes to the

- 23 A student who demonstrates sufficient academic progress according to his/her promotion plan shall be
- promoted to the next grade level unless retention is required per additional requirements for students in
- 25 third and fourth grade.⁷
- 26 If a student has not demonstrated sufficient academic progress according to his/her promotion plan by
- 27 the end of the school year, the student shall be eligible to enroll in a summer reading or learning
- program, if available. Parent(s)/guardian(s) shall be notified of a decision for retention at least ten (10)
- 29 calendar days prior to the start of the next school year if the student was enrolled in a summer program.
- 30 However, if the student wasn't enrolled in a summer program, the parent(s)/guardian(s) shall be
- 31 notified of a decision for retention at least thirty (30) calendar days prior to the start of the next school

Employees shall be provided a work environment free from sexual, racial, ethnic, disability and/or religious discrimination/harassment based on age (40+), race, color, religion, national origin, disability, creed, sex, genetic information, and retaliation. It shall be a violation of this policy for any employee or any student to discriminate against or harass an employee through disparaging conduct or communication. The following guidelines are set forth to protect employees from discrimination/harassment.

- Employee discrimination/harassment will not be tolerated.¹ Discrimination/harassment is defined as conduct, advances, gestures or words either written or spoken based on age (40+), race, color, religion, national origin, disability, creed, sex, genetic information, and retaliation related which:
 - 1. Unreasonably interferes with the individual's work or performance; or
 - 2. Creates an intimidating, hostile or offensive work environment; or
 - 3. Implies that submission to such conduct is made an explicit or implicit term of employment;
 - 4. Implies that submission to or rejection of such conduct will be used as a basis for an employment decision affecting the harassed employee.
- Alleged victims of discrimination/harassment shall report these incidents immediately.² This report should be made to the immediate supervisor except when the immediate supervisor is the offending party. If the immediate supervisor is the offending party, the report may be made to the director of schools. Allegations of discrimination/harassment shall be fully investigated (as set forth in *Complaints and Grievances 5.501*). An oral complaint may be submitted; however, such complaint must be reduced to writing to ensure a more complete investigation. The complaint should include the following information:
 - 1. Identity of the alleged victim and person accused;
 - 2. Location, date, time and circumstances surrounding the alleged incident;
 - 3. Description of what happened;
 - 4. Identity of all witnesses; and

5. Any other evidence available.

- The privacy and anonymity of all parties and witnesses to complaints will be respected. However, because an individual's need for confidentiality must be balanced with obligations to cooperate with police investigations or legal proceedings, to provide due process to the accused, to conduct a thorough investigation or to take necessary action to resolve a complaint, the identity of parties and witnesses may be disclosed in appropriate circumstances to individuals with a need to know.
- A substantiated charge against an employee shall result in disciplinary action up to and including termination. A substantiated charge against a student may result in corrective or disciplinary action up to and including suspension.
- There shall be no retaliation against any person who reports discrimination/harassment or participates in an investigation. However, any employee who refuses to cooperate or gives false information during the course of any investigation may be subject to disciplinary action. The willful filing of a false report will itself be considered harassment and will be treated as such.
- An employee disciplined for violation of this policy may appeal the decision by contacting the director of schools.

- Students residing outside the school system boundaries Rutherford County shall not be permitted to attend Rutherford County Schools with the following exceptions:¹
 - 1. Children of district employees employed by the Board of Education shall be permitted to attend, subject to specific conditions;
 - 2. Students seeking enrollment in the Rutherford County Virtual School;

- 3. If the student and his/her custodial parent/legal guardian move out of the county during the school year, the student may be permitted to remain in the Rutherford County School where s/he is enrolled through the remainder of that academic year, if recommended by the principal and approved by the Director of Schools;
- 4. If a student and his/her custodial parent are moving into Rutherford County during a semester and they request to enroll in a Rutherford County School prior to moving into Rutherford County, the Director of Schools/designee may approve such early admission if proof is submitted (lease, contract, deed, etc.) that the family will be residing in Rutherford County during the semester. If the family has not moved into Rutherford County by the end of the semester, the Director of Schools may terminate the agreement and the student shall enroll in school in his/her county of residence.
- The children of employees of the Board of Education, that reside outside of Rutherford County, may attend Rutherford County schools, subject to the following conditions:¹
 - 1. Employee requests will be considered based on available space at the requested school/zone. The child must attend the school at which the parent is employed.
 - 2. The child must attend the school at which the parent is employed. If the child's grade level is not offered at the school at which the parent is employed, then the child may attend another school within the same zone as the parent's school of employment.
 - 3. A non-resident employee desiring to enroll his/her child(ren) in the Rutherford County School system shall follow the zone exemption application process.²
 - 4. Non-resident children of employees at magnet schools will not be permitted to attend the magnet school.

- 5. If an exemption is granted for the child or children of a classified employee, the employee must reapply annually so their continued employment at the school/zone can be confirmed.

AGREEMENT FOR DEDICATION, EASEMENTS AND OPTION TO PURCHASE

This Agreement for Dedication, Easement and Covenants (this "Agreement") is executed, delivered and made effective as of March 12, 2012 (the "Effective Date"), by and between The Rutherford County Board of Education ("Board"), and Amnon Shreibman, Trustee, ("Developer"). The Board and Developer are sometimes each referred to as a "Party" and collectively as the "Parties".

WITNESSETH

WHEREAS, the Board is the owner of several tracts of property located in Smyrna, Tennessee on which the Smyrna High School is located being described more particularly in the attached Exhibit 1 (collectively the "Board Tracts"); and

WHEREAS, Developer is the owner of a tract of property adjacent to the Board Tracts in Smyrna, Tennessee, as more particularly described on Exhibit 2 (the "Shreibman Tract"); and

WHEREAS, when Smyrna High School was constructed, a private driveway to the Smyrna High School was built which has become known as Bulldog Drive and approximately one-half of the width of said driveway is located on the Board Tracts and the other approximate one-half of the width of said driveway is located on the Shreibman Tract; and

WHEREAS, the Parties have reached an agreement to dedicate each of the Party's respective portions of Bulldog Drive to the Town of Smyrna to be improved as a public road at Developer's expense and to impose certain easements, restrictions and covenants on their respective tracts to benefit both tracts and to allow for the development of a public road which will better serve both Parties' tracts and to also provide areas for additional parking for Smyrna High School and other school related activities;

NOW, THEREFORE, in consideration of the foregoing recitals, the mutual covenants herein set forth, and other good and valuable consideration, the Parties hereby agree as follows:

ARTICLE I Easements & Dedication

- 1.1 <u>Dedication for a Public Road</u>. The Board and Developer agree to execute a plat to publicly dedicate the portion of each Party's respective tracts depicted in the drawing entitled Final Plat Bulldog Drive Right-Of-Way Dedication to the Town of Smyrna which is attached as Exhibit "3".
- 1.2 <u>Temporary Construction Easement</u>. Board hereby grants and conveys to Developer a non-exclusive, temporary construction easement thirty (30) feet in width running parallel to the Board's side of Bulldog Drive as shown on Exhibit "3" and continuing in a northerly direction for a length of eight hundred (800) feet beyond the north end of Bulldog Drive along the common property line between the Board Tracts and Shreibman Tract. The easement contained in this Section 1.2 shall automatically expire on the earlier to occur of (a) completion of improvements on the Bulldog Drive or (b) eighteen (18) months from the date of this Agreement.

1.3 Developer Obligations.

- (i). Developer shall be solely responsible for the improvements to the road to be built in accordance with the requirements of the Town of Smyrna over, across, and through the existing Bulldog Drive as shown on Exhibit "3". Developer shall complete the construction of said road by no later than eighteen (18) months of the later date that either Party executed this Agreement unless extended by mutual agreement of the Parties. Developer shall be solely responsible for all costs required for construction and all costs of all infrastructure required in regards thereto, including, but not limited to curbs, gutters, drainage systems, relocation and/or upsizing of utility lines, traffic signalization, road signage, drainage systems, and landscaping.
- (ii). Developer shall be required to construct a sidewalk along the Board's side of the new roadway in a manner and location acceptable to the Board's Assistant Director of Engineering. The sidewalk must be installed in a manner and at an elevation which will allow the free flow of surface water across the sidewalk and will not create ponding. In the event the Board's Assistant Director for Engineering determines that any tree limbs require cutting to provide sufficient headroom for the use of the sidewalk, Developer shall be responsible to cut limbs in accordance with the Assistant Director of Engineering's directions.
- (iii). The Developer shall construct the road improvements in a manner that does not increase any drainage of surface water onto the Board Tracts.
- (iv). Any utility line modifications must be constructed in accordance with designs that ensure sufficient capacity for Smyrna High School. Utility line work must be conducted in a manner reasonably acceptable to the Board and which will not result in any utility outages when school is in session or school activities are occurring. Developer shall obtain the Board's Assistant Director for Engineering's approval for all utility designs prior to undertaking construction which approval shall not be unreasonably withheld or delayed..

- (v). Developer shall undertake construction in a manner that does not unreasonably interfere with the beginning and ending of the school days, and shall coordinate construction so that it is undertaken in a manner reasonably acceptable to the Board. Developer shall undertake construction of Bulldog drive in a manner that leaves Bulldog Drive open to traffic and passable when school is in session and official school functions are occurring.
- (vi). Developer shall also be responsible to cut down and grade, at Developer's expense, an elevated area near the Smyrna High School stadium as directed by the Board's Assistant Director for Engineering.
- (vii). All trees within said easement, or adjacent to the easement, are to remain and Developer shall take reasonable measures to safeguard them during construction.
- (viii). Developer shall be required to restore the Board's property to its present condition or better following construction, to replace any damaged trees inadvertently damaged, and to seed and straw any disturbed ground following completion of construction in a manner acceptable to the Board. In the event any slope requires matting or sod under good local engineering practices to prevent erosion, Developer shall be responsible to install the same at Developer's expense.
- (ix). Developer shall be responsible to undertake all work hereunder in a manner that does not increase the flow of surface water onto the Board's Tracts, creates erosion on the Board's tracts, or results in ponding of water on the Board's Tracts.
- (x) Developer shall not use Bulldog drive for construction traffic except as necessary for the construction of the road improvements themselves. Developer shall provide a construction drive at the entrance of Bulldog Drive on Developer's Tract for construction traffic for the construction of the planned apartments and any future development on Developer's Tract.
- (xi). Developer shall coordinate all work regarding Bulldog Drive and associated infrastructure with the Board's Assistant Director For Engineering. Developer shall perform all work utilizing local customary best engineering and building practices and in compliance with all applicable codes.

ARTICLE II Easement for School Use

2.1 Easement. Developer grants the Board a non-exclusive, temporary easement to utilize the commercially zoned areas and undeveloped areas of Developer's Tract depicted in the attached Exhibit "4" for parking and other school related activities. Said easement shall terminate upon such time as Developer transfers, deeds or leases 18 acres, or more, of the portion of the Developer's Tract which is currently zoned commercial (C-2) or such earlier time as the Parties mutually agree. Exhibit "4" depicts the portion of the Developer's Tract currently zoned commercial (C-2).

ARTICLE III

Option to Purchase

Exclusive Option to Purchase. As part of the consideration of the execution of this Agreement by the Board, Developer hereby grants the Board an exclusive option to purchase the parcel of property depicted in the attached Exhibit "5" (the "Optioned Property"), or such portion thereof as the Board chooses to purchase ("Option to Purchase"). The purchase price for said property, or the portion which the Board determines to purchase, shall be Ten (\$10) Dollars. The Developer may claim any difference between the purchase price and the market value of the property as a charitable donation. The Board may exercise the Option to Purchase after the following occurs: the sale, transfer, or lease of 18 acres, or more, of the commercially zoned (C-2) property depicted in Exhibit "4" by Developer. Upon the Developer transferring, leasing or selling 18 acres, or more, of the commercially zoned (C-2) area depicted in Exhibit "4," the Developer shall give written notice to the Board that the Board has the right to purchase the property depicted on Exhibit "5", or a portion thereof, for the purchase price of Ten (\$10) Dollars pursuant to this Agreement. The notice shall be sent as provided in this Agreement. Upon the Board's actual receipt of said written notice, the Board shall have one (1) year in which to exercise the Option to Purchase. If the Board does not exercise the Option to Purchase all, or any portion thereof, within said one (1) period after actual receipt of the written notice from Developer of the sale of 18 acre, or more, of the commercially zoned area depicted in Exhibit "4", the Option to Purchase shall expire. Developer is required to obtain releases of any deeds of trusts and liens against the property described in Exhibit "5" to enable the Board to purchase the same free and clear of all deeds of trust and liens. Developer further covenants and agrees not to place any restrictions against any portion of the property depicted in Exhibit "5" so long as this Option to Purchase has not terminated. Notwithstanding the above, if the Board of Education has exercised the Option to Purchase to purchase the Optioned Property, in whole or in part, and accountants for Developer suggest structuring the transfer of the property as a donation from the Developer to the Board in a different manner that results in no cost to the Board, the Board agrees to cooperate with Developer to effectuate the said donation.

ARTICLE III Defaults and Remedies

3.1 <u>Defaults</u>. If either Party (the "Defaulting Party") should fail to observe any of the terms, conditions, restrictions or provisions of, or should fail to perform any of its covenants or obligations under this Agreement within a period of thirty (30) days after written notice of such non-performance from any other Party, then the Defaulting Party shall be in default under this

Agreement. If a default has occurred and is not cured within the time period specified in this Section 3.1, then the non-defaulting Party shall have all of the rights and remedies afforded to it by law or in equity, and also any other right or remedy set forth in this Agreement.

- 3.2 <u>Attorneys' Fees.</u> In the event any Party brings an action to interpret or enforce any term or condition of this Agreement, the prevailing Party shall be entitled to recover, in addition to any relief awarded by the court, its reasonable attorneys' fees and court costs from the non-prevailing Party.
- 3.3 <u>Indemnity by Developer</u>. The Developer shall hold harmless and indemnify the Board from and against any and all claims, damages, liability, costs, causes of action and expenses (including reasonable attorneys' fees) arising out of: (a) the exercise by the Developer (and its tenants, occupants, contractors, employees and invitees) of its rights pursuant to this Agreement; and/or (b) any violation by the Developer (and its tenants, occupants, contractors, employees and invitees) of the terms or conditions of this Agreement.

ARTICLE IV Miscellaneous Provisions

4.1 Notices. Any notice or other communication required or permitted to be given under this Agreement shall be in writing and shall be deemed effective upon delivery (or refusal of delivery) when transmitted to the address(es) set forth by a nationally recognized overnight delivery service (such as FedEx or UPS) or by certified mail, postage prepaid, return receipt requested. Any Party may change its address for notice by giving written notice thereof to the other Party at least ten (10) business days prior to the effective date of such change of address. - 4.2 <u>Notice upon Transfer</u>. Upon the conveyance of any portion of the Developer Tract, the Developer shall deliver notice of such transfer to the Board in the manner described in Section 3.1 above. Until such time as notice of such transfer is provided to the Board, the Developer shall remain primarily responsible for all obligations applicable to the Developer Tract.
- 4.3 <u>Successors and Assigns</u>. This Agreement shall inure to the benefit of and be binding upon the respective successors and assigns (including successive, as well as immediate, successors and assigns) of the Parties.
- 4.4 Governing Law. This Agreement shall be governed by and construed in accordance with the laws of the State of Tennessee, without regard for its conflict of laws principles. For all litigation, disputes and controversies which may arise out of or in connection with this Agreement, the undersigned hereby waive the right to trial by jury and consent to the jurisdiction of the courts of Rutherford County, Tennessee.
- 4.5 <u>Duplicate Originals</u>. This Agreement may be executed in one or more counterparts, each of which shall be deemed to be a duplicate original, but all of which, taken together, shall constitute a single instrument. Signature pages may be detached from multiple separate counterparts and attached to a single counterpart so that all signature pages are physically attached to the same document.
- 4.6 <u>Severability</u>. If any provision of this Agreement or the application of any provision to any party or any circumstance shall be determined to be invalid or unenforceable, then such determination shall not affect any other provision of this Agreement or the application of said provision to any other party or circumstance, all of which other provision shall remain in full force

and effect.

- 4.7 <u>Amendments in Writing.</u> No change, amendment, termination or attempted waiver of any of the provisions of this Agreement shall be binding upon any Party unless in writing and signed by the Party(ies) to be charged.
- 4.8 Agreement for Exclusive Benefit of Parties. The provisions of this Agreement are for the exclusive benefit of the Parties (and their successors and assigns) and not for the benefit of any other persons or parties, and this Agreement shall not be deemed to have conferred any rights, express or implied, upon any other persons or parties.
- 4.9 <u>Covenants Run With the Land</u>. It is intended that the covenants, easements, agreements, promises and duties of each Party, as set forth in this Agreement, shall be construed as covenants and not as conditions and that all such covenants shall run with the land and constitute equitable servitudes.
- 4.10 <u>Estoppel Certificates</u>. Each Party agrees that within fifteen (15) days of written request from time to time of the other Party, it will issue to a prospective mortgagee of such other Party or to a prospective successor Party to such other Party, an estoppel certificate stating:
 - (a) whether the Party to whom the request has been directed knows of any default by the requesting Party under this Agreement, and if there are known defaults, specifying the nature thereof;
 - (b) whether this Agreement has been assigned, modified or amended in any way by such party (and if it has, then stating the nature thereof); and
 - (c) that to the requested party's knowledge this Agreement as of that date is in full force and effect.

Such statement shall act as a waiver of any claim by the party furnishing it to the extent such claim is based upon facts contrary to those asserted in the estoppel statement; however, such estoppel statement shall in no event subject the party furnishing it to any liability whatsoever, notwithstanding the negligent or otherwise inadvertent failure or such party to disclose correct and/or relevant information.

- 4.11 Agreement Shall Continue Notwithstanding Breach. It is expressly agreed that no breach of this Agreement shall entitle any party to cancel, rescind or, otherwise terminate this Agreement. However, such limitation shall not affect in any manner any rights or remedies to which a party may be entitled hereunder by reason of any such breach.
- 4.12 <u>Term.</u> Subject to the provision hereinbelow, this Agreement and the rights, obligations and liabilities created herein shall extend for a term of seventy-five (75) years from the date hereof and shall automatically be extended for terms of ten (10) years each thereafter unless all

Parties mutually agree to terminate this Agreement. Notwithstanding the foregoing, the easements contained in this Agreement shall be perpetual to the extent permitted by law and unless otherwise specified herein.

ELIMINATION OF DIVERSITY, EQUITY, AND INCLUSION INITIATIVES FROM TENNESSEE K-12 EDUCATION SETTINGS

WHEREAS, the Rutherford County Schools Board of Education is the local governmental body responsible for providing a public education to the students and families of Rutherford County; and

WHEREAS, diversity, equity, and inclusion (DEI) initiatives have been embedded in various aspects of K-12 education across Tennessee; and

WHEREAS, many businesses and organizations, including prominent companies in education and other sectors, are reevaluating or scaling back their diversity, equity, and inclusion (DEI) initiatives due to concerns about their effectiveness, legal risks, and alignment with core organizational objectives; and

WHEREAS, the Supreme Court's decision in *Students for Fair Admissions, Inc. v. President and Fellows of Harvard College* has triggered national discussions about the role of diversity initiatives in both higher education and K-12 settings, with many stakeholders calling for a reassessment of policies that prioritize demographic characteristics over individual merit and achievement; and

WHEREAS, Tennessee Code Annotated (TCA) § 49-1-302(g) directs the Tennessee State Board of Education to implement policies promoting educator diversity, including strategies for recruitment and retention of minority educators, setting local goals based on student diversity, and monitoring educator diversity across the state; and

WHEREAS, the policies derived from TCA § 49-1-302(g) emphasize aligning LEA staffing efforts with the demographic composition of their student populations, thus influencing local education practices and priorities related to diversity;

NOW, THEREFORE, BE IT RESOLVED, that the Rutherford County Schools Board of Education calls on the Tennessee General Assembly to delete TCA § 49-1-302(g) in its entirety, eliminating state-imposed requirements related to educator diversity goals, recruitment strategies, and statewide monitoring systems that prioritize demographic characteristics over professional qualifications and academic outcomes; and

AND BE IT FURTHER RESOLVED, that the Rutherford County Schools Board of Education urges the Tennessee General Assembly to reevaluate existing policies and rules stemming from TCA § 49-1-302(g).
